This fifth supplement (the **Supplement**) to the Base Prospectus dated 5 July 2013, as previously supplemented by the first supplement dated 16 July 2013, the second supplement dated 13 August 2013, the third supplement dated 20 March 2014 and the fourth supplement dated 2 May 2014 (together, the **Base Prospectus**), constitutes a supplement for the purposes of Article 13.1 of Chapter 1 of Part II of the Luxembourg Act dated 10 July 2005 on prospectuses for securities, as amended (the **Prospectus Act**) and is prepared in connection with the €60,000,000,000 Euro Medium Term Note Programme (the **Programme**) established by UniCredit S.p.A. (**UniCredit** and, in the case of Notes issued by UniCredit Bank Ireland p.l.c. and UniCredit International Bank (Luxembourg) S.A., the **Guarantor**), UniCredit Bank Ireland p.l.c. (**UniCredit Ireland**) and UniCredit International Bank (Luxembourg) S.A. (**UniCredit International Luxembourg**) (each an **Issuer** and together the **Issuers**). Terms defined in the Base Prospectus have the same meaning when used in this Supplement.

This Supplement is supplemental to, and should be read in conjunction with, the Base Prospectus.

Each of the Issuers and the Guarantor accepts responsibility for the information contained in this Supplement. To the best of the knowledge of each of the Issuers and the Guarantor (which have taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Purpose of the Supplement

The purpose of the submission of this Supplement is to (i) update the "Documents Incorporated by Reference" section of the Base Prospectus to incorporate by reference the UniCredit unaudited consolidated interim report as at 31 March 2014, the UniCredit audited consolidated financial statements as at and for the year ended 31 December 2013 and recent press releases relating to UniCredit, (ii) update the "Summary Note" section of the Base Prospectus, (iii) update

the "Description of UniCredit and the UniCredit Group" section of the Base Prospectus with certain recent information available on UniCredit and (iv) update the "General Information" section of the Base Prospectus.
