# **Key Information Document**

## Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

## 1. What is this product?

#### Type

An Over the Counter (OTC) derivative contract - FX Option (American)

## Objectives

This OTC derivative is used for managing foreign currency risks.

An FX Option (American) is an agreement between two contracting parties (client/UniCredit Bank Austria AG) which gives the buyer of the FX Option (American) the right but not the obligation to exchange an agreed amount of one currency for another currency at an agreed fixed rate on any future date prior to and including an agreed future date.

With the purchase of an FX Option (American), you acquire the right but not the obligation to buy an amount of a specific currency (e.g. RUB notional amount) and sell an amount of another currency (e.g. EUR notional amount) at an agreed fixed rate (strike rate) on any future date prior to and including the agreed future date (settlement date). You may exercise your right at any time prior to and including an agreed date (expiry date).

In order to purchase this right, you will pay an non-refundable option premium.

Whether or not you exercise the FX Option (American), you will not get back the option premium you paid.

Sample product terms are set out below and are based on legally predefined or realistic assumptions, which may not match your specific contract details, e.g. your notional amounts, your option premium, etc.

## 2. What are the risks and what could I get in return?

## **Risk Indicator**

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.



Please note that there is a currency risk if the product is denominated in a foreign currency. In such a case you will pay and/or receive payments in a foreign currency which means that the final return will depend on the exchange rate of the two currencies. The above indicator does not take currency risk into account.

In some circumstances you may be required to make payments to pay for losses. The total loss you may incur may be significant.

## 3. What happens if UniCredit Bank Austria AG is unable to pay out?

Counterparties of derivative transactions are exposed to the risk that UniCredit Bank Austria AG becomes unable to discharge its obligations under the transaction, for example in the case of an insolvency (inability to pay or overindebtedness) or in the case resolution measures are taken by an authority against the credit institution. Such a decision to take resolution measures can, for example, be taken if the assets of the institution are less than its liabilities, where it is unable or will, in the near future, be unable to pay its debts or other liabilities as they fall due, or where it requires extraordinary public financial support. Where resolution measures are taken, the competent resolution authority can decide on an early termination of the derivative transaction. ## 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself for the recommended holding period. The figures assume a notional amount of EUR 10,000. The figures are estimates and may change in the future.

## 5. How long should I hold it and can I take money out early?

#### Recommended holding period: 1 Year

The recommended holding period is equal to the contractually agreed term. You are not entitled to terminate the product unilaterally before the end of the contractually agreed term. This does not apply in case you have contractually agreed with UniCredit Bank Austria AG that one party or both parties have the right to prematurely terminate this product upon notice to the other party and subject to a compensation payment (contractual early termination clause).
