You are about to purchase a product that is not simple and may be difficult to understand.

1. What is this product?

Type

An Over the Counter (OTC) derivative contract – Sustainability linked Interest Rate Swap Protetto

Objectives

Interest Rate Swaps Protetto are used for managing interest rate risks arising from a indebtedness linked to sustainability objectives.

A Sustainability linked Interest Rate Swap Protetto is an agreement between two contracting parties (client/UniCredit S.p.A.) to exchange interest payments, calculated on a notional amount during the contractually agreed term. The interest payments are exchanged at certain agreed dates. Terms of up to ten years are customary. The term of this agreement is divided into individual interest periods, which are determined by the period applicable to the reference rate.

In a Sustainability linked Interest Rate Swap Protetto you pay a fixed interest rate and receive a floating interest rate, equal to the higher of a reference rate (e.g. EURIBOR) and an agreed floor rate (if applicable plus a spread) in the same currency. The fixed interest rate is determined when the contracting parties enter into the swap. The reference rate is reset two banking days before the start of a respective interest period. Any reference rate with applicable periods (e.g. 3 month EURIBOR) can be selected as base for the floating interest payments.

The contract includes client's commitment of to achieve specific sustainability objectives, which corresponds to a reduction (bonus) or increase (malus) applied to the Fixed interest Rate and/or to the Floating interest Rate, based – respectively – on the achievement or not-achievement of the sustainability objectives.

In general the parties agree to offset the two interest payments, so that only the amount in excess at the end of each interest period is actually paid. If the floating interest rate and/or the fixed interest rate is negative, the direction of the respective interest payment changes.

The notional amount of the Sustainability linked Interest Rate Swap Protetto serves merely to calculate the respective interest payment. There is no amount payable/receivable equal to the notional amount.

You can enter into this product also in a foreign currency.

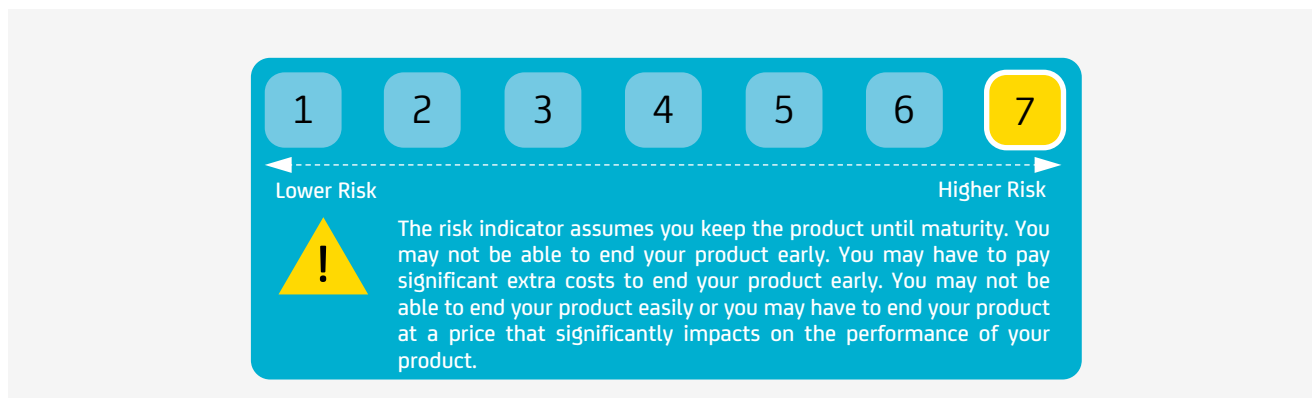

2. What are the risks and what could I get in return?

Risk Indicator

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

3. What happens if UniCredit S.p.A. is unable to pay out?

The investment on this product is exposed to the credit risk, meaning in the case UniCredit S.p.A., as a result of the reduction of its solvency due to financial trouble, bankruptcy, insolvency or over-indebtedness, becomes unable to fully repay the amounts that are due in relation to this product. In the case, you may lose in full or in part the payments you made or suffer unlimited losses.

Furthermore, according to the applicable law on "Bail-in", the competent resolution authorities may take certain resolution measures, such as the early termination of the derivative transactions. In this case, you are exposed to the risk of partial or complete reduction of your claim or in a conversion of your claim in to equity, in a permanent way, even without a formal insolvency declaration by UniCredit S.p.A.

4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the performance of the product. The total costs take into account one-off, ongoing and incidental costs.

5. How long should I hold it and can I take money out early?

Recommended holding period: 10 Years

The recommended holding period is equal to the contractually agreed term. You are not entitled to terminate the product unilaterally before the end of the contractually agreed term.

This does not apply in case you have contractually agreed with UniCredit S.p.A. that one party or both parties have the right to prematurely terminate this product upon notice to the other party and subject to a compensation payment (contractual early termination clause).
