You are about to purchase a product that is not simple and may be difficult to understand.

# 1. What is this product?

## Туре

An Over the Counter (OTC) derivative contract - Opzione europea put eur/call divisa (Import)

### Term

The product has a fixed contractually agreed term and will terminate after 6 months.

### Objectives

Opzione europea put eur/call divisa (Import) products are used for managing foreign currency risks.

An Opzione europea put eur/call divisa (Import) is an agreement between two contracting parties (client/UniCredit S.p.A.) which gives the buyer of the Opzione europea put eur/call divisa (Import) the right but not the obligation to exchange an agreed amount of one currency for another currency at an agreed fixed rate on an agreed future date.

With the purchase of an Opzione europea put eur/call divisa (Import), you acquire the right but not the obligation to buy an amount of a specific currency (e.g. USD notional amount) and sell an amount of another currency (e.g. EUR notional amount) at an agreed fixed rate (strike rate) on an agreed future date (settlement date). You may exercise your right on an agreed date (expiry date).

In order to purchase this right, you will pay an non-refundable option premium.

Whether or not you exercise the Opzione europea put eur/call divisa (Import), you will not get back the premium you paid.

# 2. What are the risks and what could I get in return?

### **Risk Indicator**

#### 3. What happens if UniCredit S.p.A. is unable to pay out?

The investment on this product is exposed to the credit risk, meaning in the case UniCredit S.p.A., as a result of the reduction of its solvency due to financial trouble, bankruptcy, insolvency or over-indebtedness, becomes unable to fully repay the amounts that are due in relation to this product. In the case, you may lose in full or in part the payments you made or suffer unlimited losses.

#### 5. How long should I hold it and can I take money out early? Recommended holding period: 6 Months

The recommended holding period corresponds to the contractually agreed term. You are not entitled to unilaterally terminate the product prematurely. However, the right of early termination may be agreed for one or both contracting parties. In the event of an agreed early termination, you will either receive or pay a compensation payment, which is made up of the market value of the product and the termination costs, including a margin earned by the bank. Significant additional costs may be incurred.
