You are about to purchase a product that is not simple and may be difficult to understand.

1. WHAT IS THIS PRODUCT?

TYPE

An Over the Counter (OTC) derivative contract - FX Forward with Time Option

The product has a fixed contractually agreed term and will terminate after 1 year.

OBJECTIVES

FX Forward with Time Option products are used for managing foreign currency risks.

An FX Forward with Time Option is an agreement between two contracting parties (client/UniCredit Bank GmbH) to exchange an agreed amount of one currency for another currency at an agreed fixed rate within an agreed period of time.

In an FX Forward with Time Option, you sell an amount of a specific currency (e.g. CZK notional amount) and buy an amount of another currency (e.g. EUR notional amount) at an agreed fixed rate (forward rate) within an agreed period of time.

You have the right to decide for one full or multiple partial settlements of the notional amount at any time within the agreed period of time.

The residual notional amount, not settled by the end of the period of time, will be automatically settled on the settlement date.

Sample product terms are set out below and are based on legally predefined or realistic assumptions and may not match your specific contract details.

2. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

RISK INDICATOR

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.







Be aware of currency risk. You may pay and/or receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

In some circumstances you may be required to make payments to pay for losses. The total loss you may incur may be significant.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes, which have been calculated based on simulations using the past performance of the currency pair over the past 5 years. The stress scenario shows what you might get back or pay in extreme market circumstances.

3. WHAT HAPPENS IF UNICREDIT BANK GMBH IS UNABLE TO PAY OUT?

Counterparties of derivative transactions are exposed to the risk that UniCredit Bank GmbH becomes unable to discharge its obligations under the transaction, for example in the case of an insolvency (inability to pay or overindebtedness) or in the case resolution measures are taken by an authority against the credit institution. Such a decision to take resolution measures can, for example, be taken if the assets of the institution are less than its liabilities, where it is unable or will, in the near future, be unable to pay its debts or other liabilities as they fall due, or where it requires extraordinary public financial support. Where resolution measures are taken, the competent resolution authority can decide on an early termination of the derivative transaction. 4. WHAT ARE THE COSTS?

5. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 year

The recommended holding period corresponds to the contractually agreed term. You are not entitled to unilaterally terminate the product prematurely. However, the right of early termination may be agreed for one or both contracting parties. In the event of an agreed early termination, you will either receive or pay a compensation payment, which is made up of the market value of the product and the termination costs, including a margin earned by the bank. Significant additional costs may be incurred.
