PURPOSE

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

1. WHAT IS THIS PRODUCT?

TYPE

An Over the Counter (OTC) derivative contract - Forward Differenziale (Export)

TFRM

The product has a fixed contractually agreed term and will terminate after 6 months.

OBJECTIVES

Forward Differenziale (Export) products are used for managing foreign currency risks.

An Forward Differenziale (Export) is an agreement between two contracting parties (client/UniCredit S.p.A.) to exchange an agreed amount of one currency for another currency at an agreed fixed rate on an agreed future date.

In an Forward Differenziale (Export), you sell an amount of a specific currency (e.g. CZK notional amount) and buy an amount of another currency (e.g. EUR notional amount) at an agreed fixed rate (NDF rate) on an agreed future date (settlement date).

Instead of physical settlements of the notional amounts, you will make or receive a payment of a net cash settlement amount on the settlement date.

The net cash settlement amount represents the difference in value between the CZK notional amount converted into the settlement currency at the reference rate (i.e. spot reference rate that is observed on an agreed pricing source) and the CZK notional amount converted into the settlement currency (e.g. EUR) at the NDF rate at expiry date.

If the reference rate is determined above the NDF rate at expiry date, you will receive the net cash settlement amount in the settlement currency at the settlement date.

If the reference rate is determined below the NDF rate at expiry date you will pay the net cash settlement amount in the settlement currency at the settlement date.


2. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

RISK INDICATOR

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



We have classified this product as 7 out of 7, which is the highest risk class.

3. WHAT HAPPENS IF UNICREDIT S.P.A. IS UNABLE TO PAY OUT?

The investment on this product is exposed to the credit risk, meaning in the case UniCredit S.p.A., as a result of the reduction of its solvency due to financial trouble, bankruptcy, insolvency or over-indebtedness, becomes unable to fully repay the amounts that are due in relation to this product. In the case, you may lose in full or in part the payments you made or suffer unlimited losses.

Furthermore, according to the applicable law on "Bail-in", the competent resolution authorities may take certain resolution measures, such as the early termination of the derivative transactions. 5. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 6 Months

The recommended holding period corresponds to the contractually agreed term. You are not entitled to unilaterally terminate the product prematurely. However, the right of early termination may be agreed for one or both contracting parties. In the event of an agreed early termination, you will either receive or pay a compensation payment, which is made up of the market value of the product and the termination costs, including a margin earned by the bank. Significant additional costs may be incurred.
