PURPOSE

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

1. WHAT IS THIS PRODUCT?

TYPE

An Over the Counter (OTC) derivative contract – FX Callable Forward with Leverage

TERM

The product has a fixed contractually agreed term and will terminate after 1 year. However, it can be called prematurely by UniCredit Bank Austria AG.

OBJECTIVES

This OTC derivative is used for managing foreign currency risks.

An FX Callable Forward with Leverage is an agreement between two contracting parties (client/UniCredit Bank Austria AG) to exchange an agreed amount of one currency for another currency at an agreed exchange reference rate on a series of agreed future reference dates, but with a unilateral callable right during the term of the agreement on behalf of UniCredit Bank Austria AG. You do not have a callable right.

With the conclusion of an FX Callable Forward with Leverage, you sell an amount of a specific currency (e.g. CZK notional amount) and buy an amount of another currency (e.g. EUR notional amount) at a strike price which is more favorable than the respective forward rate at the time of conclusion. The amount of the CZK notional amount to be sold depends on the reference rate determined on the reference date in relation to the agreed strike price and on the agreed leverage as follows:

- if EUR/CZK is referenced at or above the strike price on a reference date, you sell the notional amount in CZK against EUR at the strike price.
- if EUR/CZK is referenced below the strike price on a reference date, you sell the notional amount multiplied by the respective leverage in CZK against EUR at the strike price.

If UniCredit Bank Austria AG exercises its callable right on one of the defined call dates, the transaction expires prematurely and all outstanding conversions after the termination date are forfeited. All conversions on the reference dates up to the first possible call date are guaranteed. On the call date, the currency exchange still takes place.

If UniCredit Bank Austria AG does not exercise its callable right on one of the defined call dates, the transaction does not expire prematurely on this call date. Termination of the trade is then only possible at the next call date.

In addition, you might agree to pay a premium to the bank; in any case, you will not get back the premium you paid.

Sample product terms are set out below and are based on legally predefined assumptions, which may not match your specific contract details, e.g. your notional amount, your term, etc.

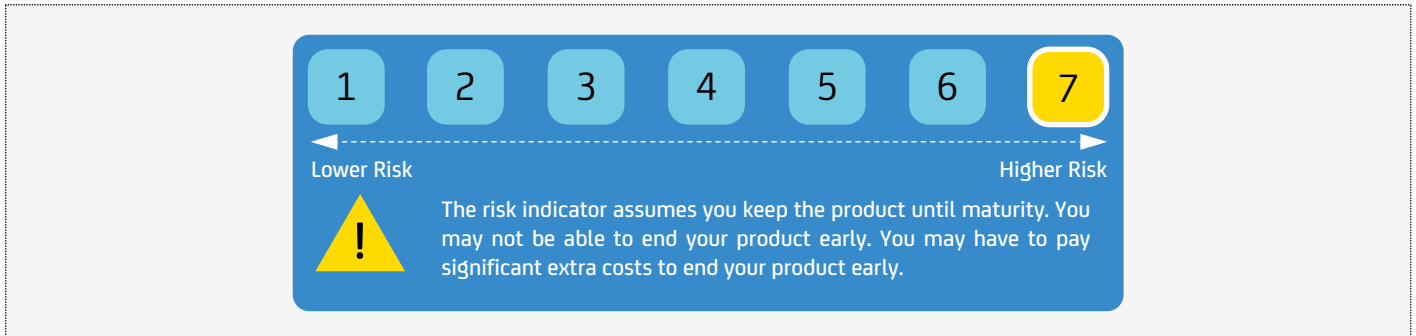
- (i) hold this product for the contractually agreed term, however taking into account of the early callable right of UniCredit Bank Austria
- (ii) are in the position to bear losses that may be unlimited and
- (iii) have knowledge of and/or past experience with this financial instrument and the financial markets.

2. WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

RISK INDICATOR

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.



Be aware of currency risk. You may pay and/or receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

In some circumstances you may be required to make payments to pay for losses. The total loss you may incur may be significant.

This product does not include any protection from future market performance so you could incur significant losses.

If we are not able to pay you what is owed, you could incur significant losses.

PERFORMANCE SCENARIOS

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The favourable, moderate, unfavourable and stress scenarios represent possible outcomes, which have been calculated based on simulations using the past performance of the currency pair over the past 5 years. The stress scenario shows what you might get back or pay in extreme market circumstances.

This product cannot be easily cashed in. This means it is difficult to estimate how much you would get back if you cash in before the end of the recommended holding period. You will either be unable to cash in early or you will make a large loss if you do so.

3. WHAT HAPPENS IF UNICREDIT BANK AUSTRIA AG IS UNABLE TO PAY OUT?

Counterparties of derivative transactions are exposed to the risk that UniCredit Bank Austria AG becomes unable to discharge its obligations under the transaction, for example in the case of an insolvency (inability to pay or overindebtedness) or in the case resolution measures are taken by an authority against the credit institution. Such a decision to take resolution measures can, for example, be taken if the assets of the institution are less than its liabilities, where it is unable or will, in the near future, be unable to pay its debts or other liabilities as they fall due, or where it requires extraordinary public financial support. Where resolution measures are taken, the competent resolution authority can decide on an early termination of the derivative transaction. In the case such early termination results in a claim of the counterparty against the credit institution, the decision of the resolution authority can lead to a partial or complete reduction of the principal amount of this claim or in a conversion of this claim in to equity (shares or other types of equity).

If UniCredit Bank Austria AG does not fulfil its obligations connected with the product or is unable to pay, you can lose part of or the full payout or can suffer an unlimited loss. This product is not protected by any deposit guarantee scheme, legal or otherwise, or any other type of guarantee.

4. WHAT ARE THE COSTS?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- The product does not change in value (0% annual return).
- A notional amount of EUR 10,000

(*) This illustrates how costs reduce your return in relation to the notional amount each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 11.0% before costs and -0.2% after costs.

5. HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 year

The recommended holding period corresponds to the contractually agreed term. You are not entitled to unilaterally terminate the product prematurely. However, the right of early termination may be agreed for one or both contracting parties. In the event of an agreed early termination, you will either receive or pay a compensation payment, which is made up of the market value of the product and the termination costs, including a margin earned by the bank. Significant additional costs may be incurred.
